[Citizen Review Panels](#) of local residents appointed by the Lieutenant Governor or Georgia Speaker of the House meet at least three times per year to oversee the program's progress.

CSRA Completes 25 TIA Transportation Construction Projects in 2024

The TIA Team and local leaders are celebrating the end of a successful 2024, with 6 TIA 1 projects and 19 TIA 2 projects completed. Overall, 83% of all TIA 1 projects and 12% of all TIA 2 projects have completed construction.

Completed project highlights include the construction of the Thomson West Bypass in McDuffie County, the construction of a frontage road along Interstate 20 in Warren County, the widening and reconstruction of 1.6 miles of SR 4/15th Street in Augusta and the resurfacing of 8.27 miles of Newtown Road in Wilkes County.

Project managers have planned an active 2025. Significant progress is expected on many projects like improvements to six Downtown Augusta streets and a bundle of five Lincoln County road resurfacings.

Jenkins County: US 25 at SR 121 Right Turn Lane Installation

Contractors have started construction on this project at the industrial park entrance. Over the past month, crews have graded the area and set a layer of base material for the new turn lane.





Richmond County: Augusta Regional Airport Improvements

Contractors have completed all major construction tasks on the airport's two projects: the expansion of the apron (a temporary 'parking area' for planes) and the rehabilitation of runway 8-26. The improvements will make it easier and quicker for aircraft to maneuver around the facility, and will make a big difference during the city's special events like The Masters PGA tournament.



Hancock County: Adam Street & Maiden Lane-Rabun Street Resurfacings

Contractors have received Notice to Proceed with construction on these two projects. Adam Street (pictured at left) will be resurfaced from Maiden Lane to SR 15, and Maiden Lane-Rabun Street will be resurfaced from Hancock Street to Hamilton Street. Watch for the crews!
