



Impacts to the TIA Program





US 27 Widening & Roundabout at SR 315 (Band 3)

- December 2022 letting
 - Final plans submitted Nov 11th
- ROW acquisition underway

- CW Matthews was low bidder
 - \$25,629,825
 - May 2020 letting
- Utility relocations in progress
- Bridge and wall work in progress

Old Cusseta Rd @ I-185 Interchange (Band 3)

- Robinson Paving was low bidder
 - \$39,683,951
 - Sept 2022 letting
- ROW acquisition underway
- Next Milestone – issuance of construction NTP

US 280 Widening (Band 3)

- Reeves Construction was the low bidder
 - \$22,878,060
 - August 2020 letting
- Paving on east side tie-in underway


Columbus TIA Project Updates

River Valley 2 (2023–2032) Project Overview






