The Georgia Department of Transportation (Georgia DOT) presents the attached annual update through calendar year 2025 for the Transportation Investment Act of 2010 for the CSRA Special District. This particular report will contain information pertaining to projects in the TIA 2: 2023 - 2032 investment list only. The Transportation Investment Act of 2010 legislation requires the submittal of an annual report by the CRP to the legislators by December 15th each year.

There were 38 completed TIA 2 projects in the CSRA during calendar year 2025. We have included a detailed project summary listing as well as highlighted project pages within this report, which can be utilized in the determination of benefits by the CRP for completed projects. Overall, 57 projects have been completed, 45 projects are in construction and 48 are in preconstruction phases.

TIA's administrative and engineering professionals and our local government partners spent the second year of the TIA 2 decade propelling Band 1 projects through preconstruction and construction phases. Regarding the region's revenues, I am happy to let you know that the CSRA region's TIA 2 collections were robust and to date we are at 28.8% over the original estimate projections. 
