The Georgia Department of Transportation (Georgia DOT) presents the attached annual update through calendar year 2025 for the Transportation Investment Act of 2010 for the River Valley Special District. This particular report will contain information pertaining to projects in the TIA 1: 2013 – 2022 investment list only. The Transportation Investment Act of 2010 legislation requires the submittal of an annual report by the CRP to the legislators by December 15th each year.

A total of 18 TIA 1 projects has been completed in River Valley to date. Four projects are currently under construction and one is in an operations phase.

TIA 1 construction activity in the River Valley region has remained steady throughout 2025. All TIA projects are still on track to be delivered by both the Georgia DOT and our valued local government partners. This is due to the continued cost savings and project management strategies the TIA staff implemented to mitigate any effects from financial challenges that occurred throughout the decade of revenue collection.

Todd Schuster, Chairman, presented the April 8, 2025, TIA-1 minutes. Kathy Carlisle made a motion to approve the minutes as presented. Tyson Begly seconded the motion. The motion was passed.

Revenue Collections Overview

Kenneth Franks, TIA Administrator, reminded the Citizen's Review Panel that there was no change in the final TIA-1 collections and timeline. The total collected amount in TIA-1 was \$512,301,207 through the end of the 10 years of the program.

The timeline for projects through TIA-1 is projected until 2027 for construction and financial close-out of all projects. Construction is expected to be completed in April 2027, while audits may be pushed to 2028.

Of the twenty-three construction projects in River Valley, four are still under construction, one is an operations project, eighteen projects are completed. The METRA project continues to be locally managed. \$311,187,903 in TIA-1 funds have been expended as of April 7, 2025.

Update of Current Projects

William Eastin, TIA Regional Coordinator, gave an update on the construction projects.

The right-of-way acquisition for the US 27 widening in Harris and Muscogee Counties is completed. Clearing, grading, and utility relocations are ongoing. Culverts have been completed. The project is about 31% complete. The estimated time of completion is May 26, 2025.

Bridge work is ongoing in the Buena Vista Road Divergent Diamond Interchange (DDI). Pouring deck in the next couple of weeks. Ramp paving and curb and gutter work continues. The Landscaping Supplemental agreement is completed. The project is 71% complete. The estimated time of completion is the end of the year.

The Old Cusseta Road at I-185 Interchange project continues with utility relocations, including water/sewer, gas, and telecom. Sound barriers are currently being removed, and bridge work has started. The project is 58% complete. The estimated time of completion is late summer of 2026.

The US Hwy 280 widening in Crisp County is completed and open to traffic.

Spider Web construction has been split into phases, with Phase 1 completed. Phase 2 Closure started on April 8, 2025. There is an active 2-year construction contract.

The METRA Park and Ride facility is completed. Operations and maintenance for METRA are ongoing. A new agreement has been executed.

There were no further questions from board members or the public.

The timeline for projects through TIA-1 is projected until 2027 for construction and financial close-out of all projects. Construction is expected to be completed in April 2027, while audits may be pushed to 2028.

Of the twenty-three construction projects in River Valley, four are still under construction, one is an operations project, and eighteen projects are completed. The METRA project continues to be locally managed. \$323,110,900 in TIA-1 funds have been expended as of August 7, 2025.

Update of Current Projects

William Eastin, TIA Regional Coordinator, gave an update on the construction projects.

The right-of-way acquisition for the US 27 widening in Harris and Muscogee Counties is completed. Clearing, grading, and utility relocations are ongoing. Culverts have been completed. The project is about 31% completed and the estimated time of completion is May 26, 2025.

The US 27 Widening & Roundabout at SR 315 was let by Robinson paving. Clearing, grading, and utility relocations are ongoing, as week as storm drain work. The base course was installed on the south side and a paving plan revision is underway.

Wall design work is being completed on the interstate median on the Buena Vista Road Divergent Diamond Interchange (DDI). Curb and gutter, sidewalk, and storm drain work continues. The contractor requested time and cost.

The Old Cusseta Road at I-185 Interchange project continues with utility relocations and storm drain work. Bridge beam setting and paving of Old Cusseta Road will be completed this month, August 2025.

Spider Web construction has been split into phases, with Phase 1 completed. Phase 2 Closure started on April 8, 2025. There is an active 2-year construction contract.

The METRA Park and Ride facility is completed. Operations and maintenance for METRA are ongoing. A new agreement has been made.

There were no further questions from board members or the public.

Revenue Collections Overview

Kenneth Franks, TIA Administrator, reminded the Citizen's Review Panel that there was no change in the final TIA-1 collections and timeline. The total collected amount in TIA-1 was \$512,301,207 through the end of the 10 years of the program.

The timeline for projects through TIA-1 has been projected until 2027 for construction and financial close-out of all projects. Construction is expected to be completed in 2027, while the financial closure of projects may be pushed to 2028.

Of the twenty-three construction projects in River Valley, four are still under construction, one is an operations project, and eighteen projects are completed. The METRA project continues to be locally managed. \$331,838,134 in TIA-1 funds have been expended as of November 26, 2025.

Update of Current Projects

William Eastin, TIA Regional Coordinator, gave an update on the construction projects.

Clearing, grading, and utility relocations for the US 27 widening in Harris and Muscogee counties are ongoing. Working on staging for side road work and on the base course and drainage for the new roundabout. The paving plan is also underway. The project is expected to be completed in mid-2026.

Ramp paving is underway on the Buena Vista Road Divergent Diamond Interchange (DDI). Curb and gutter, and interchange landscaping are underway. The contractor was granted a 6-month time extension.

Paving of the Old Cusseta Road at the I-185 Interchange project is underway, and drainage structure and wall work continue. Bridge painting of Old Cusseta Road is underway. The project is 72% completed and expected to be completed in the spring of 2026.

Spider Web construction has been split into phases, with Phase 1 completed. Phase 2 started on April 8, 2025. There is an active 2-year construction contract.

The METRA Park and Ride facility is completed. Operations and maintenance for METRA are ongoing, but they are expected to expend the remaining of their funds soon.

End of Year Reporting

Kenneth Franks presented the Annual Project Status Report for TIA 1 in 2025. The annual report will need to be posted to the Department of Revenue's Website by December 15th. Tyson Begly made a motion to approve the report. Kathy Carlisle seconded the motion. The motion was passed.

There were no further questions from board members or the public.

The board closed the TIA-1 meeting and then conducted business for TIA-2.
