Dear Citizens Review Panel Members:

The Georgia Department of Transportation (Georgia DOT) presents the attached annual update through calendar year 2025 for the Transportation Investment Act of 2010 for the River Valley Special District. This particular report will contain information pertaining to projects in the TIA 2: 2023 – 2032 investment list only. The Transportation Investment Act of 2010 legislation requires the submittal of an annual report by the CRP to the legislators by December 15<sup>th</sup> each year.

There were three TIA 2 projects completed in the River Valley region during calendar year 2025. As of this letter, a total of four TIA 2 projects has been completed, four projects are under construction, 34 are in preconstruction phases and one is in an operations phase.

TIA's administrative and engineering professionals and our local government partners have spent much of 2025 continuing to move TIA 2's Band 1 and 2 projects through preconstruction. Regarding the region's revenues, I am happy to let you know that the River Valley region's TIA 2 collections were robust and to date they are 16.5% over original estimate projections. While this is positive news, the TIA staff will continue working in the spirit of 'cautious optimism,' maintaining fiscal planning and project management strategies that will ensure sustained success throughout the entire term.

#### Call to Order and Welcome

Todd Schuster, Chairman, welcomed everyone to the meeting. He noted that the TIA-2 meeting remains separate from the TIA-1 meeting and that both programs would continue to be reported separately to the state.

#### **Approval of Minutes**

Todd Schuster, Chairman, presented the April 8, 2025, TIA-2 minutes. Kathy Carlisle made a motion to approve the minutes as presented. Tyson Begly seconded the motion. The motion was passed.

#### **Revenue Collections Overview**

Kenneth Franks, TIA Administrator, gave the update to the Citizen's Review Panel on the TIA-2 collections and timeline through February 2025. Collections were 16.5% above estimates. A total of \$150,287,712 had been collected.

River Valley has forty-five projects in TIA-2. Twenty-nine projects are in planning and design, four are in construction, and one is completed. Total expenditure for the projects as of April 7, 2025, is \$16,972,662.

#### **Update of Current Projects**

William Eastin, TIA Regional Coordinator, gave an update on resurfacing job lets and preconstruction updates for projects in TIA-2.

The Chalybeate Springs Road in Talbot County resurfacing project is under construction and 98% completed. The final inspection is underway. Oxford will begin construction on Lower Lumpkin Road in

Quitman County this month, in April 2025. Letting will start in June 2024. Oxford will begin construction in Clay and Randolph Counties this summer and letting began in December 2024. Dooly and Crisp Counties' Cooney Road resurfacing projects have four sections from Cotton Street in Vienna to SR 300 in Crisp County. Two sections are in Band 1, while the remaining two are in Band 2.

There are many projects in preconstruction. The Harris County SR 315 from Hart Drive to Hamilton, Mulberry Grove Rd project is receiving improvements. Concept alternative reports were developed for intersection improvements for SR 315 at the SR 219 Intersection. SR 26 Passing Lane improvements in Chattahoochee/Marion Counties and US 82 Passing Lane improvements in Randolph/Quitman Counties are underway. The Buena Vista Road improvements in Muscogee County and the Manchester Expressway/US 27 Alternative at the County Line Road Interchange are underway. Andrews Road and Brennan Road improvements have approved concept reports and will hold public meetings in May 2025. University Ave Road Diet/Streetscape and US 80 ramp improvements are underway. 2nd Avenue improvements include two Band 2 projects, one of which is a GDOT deep surface reclamation or a Full-Depth Reclamation project, and the second is a TIA sidewalk project. The resurfacing project will require a right-of-way analysis.

The right-of-way and design processes are underway for the Webster and Schley Counties' bridge replacements. The Marion County Buena Vista Downtown project is currently working on final plans and will begin letting in January 2026. Manchester Expressway in Harris County preconstruction project is working on final plans, which will be submitted by the end of the month and will begin letting in July 2025.

Need, Effectiveness, and Logical Termini (NELT) environmental documentation is being developed for the phase of the US 280 widening from Felder Street to District Line Road in Sumter County, as well as preliminary plans. The US 280 widening from District Line Road to SR 195 and the US 280 widening from SR 195 to Lake Blackshear are both working on concept and environmental screening and will hold Public Information Open Houses (PIOH) this summer.

Will Johnson from the City of Columbus gave updates on design work for local let projects. Projects with executed agreements involve Steam Mill Road, Whitesville Road widening, Columbus River Walk repaving and maintenance, South Lumpkin Road streetscape, 13th Ave/17th St/Blvd improvements, Liberty Theater Enhancements, and the 5th Avenue Trail Connector. The preliminary bridge layout was accepted for Steam Mill Road and the right-of-way was approved. No right-of-way is needed for the 5th Avenue Trail Connector. Finally, construction is completed for the Buck Creek Bypass of Macon County, while the Montezuma airport project is working on a bid package and will be bid this summer. Ed Davis/Rustin Lake Road project is finalizing a bid package. The Hospital Rd resurfacing project in Stewart County is 100% completed.

#### **Update of Current Projects**

William Eastin, TIA Regional Coordinator, gave an update on resurfacing job lets and preconstruction updates for projects in TIA-2.

The Chalybeate Springs Road in Talbot County is 100% completed. Lower Lumpkin Road in Quitman County began letting in June 2024. Striping and grassing have been completed, and final inspection will take place in August 2025. Cotton Hill Road in Clay and Randolph Counties will begin construction between September and October 2025. Dooly and Crisp Counties' Cooney Road resurfacing project is preparing a plan package and plans to submit it to GDOT the week of August 11, 2025.

There are many projects in preconstruction. The Harris County SR 315 from Hart Drive to Hamilton, Mulberry Grove Rd, and SR 219 Intersection improvement projects are underway. A public meeting is scheduled for the SR 219 Intersection improvements project on August 14 at Creekside Schools. The Buena Vista Road improvements, University Ave Road Diet/Streetscape, and 2nd Avenue improvement projects are under concept development. The Buena Vista Road and University Ave Road Diet/Streetscape projects are both multi-use trails.

The right-of-way and final design processes are underway for the Webster and Schley Counties' bridge replacements. The Marion County Buena Vista Downtown project is currently working on final plans and right-of-way and will begin letting in January 2026. The Manchester Expressway in Harris County at Central Church Road project had a low bid of \$360,474,51 and let in July 2025. The Muscogee County Williams Road and Cusseta Road is in Phase 2 and is procuring a design.

Preliminary Plans for the US 280 widening from Felder Street to District Line Road in Sumter County are being developed. The US 280 widening from District Line Road to SR 195 and the US 280 widening from SR 195 to Lake Blackshear are both working on concept and environmental screening and will hold Public Information Open Houses (PIOH) on August 21, 2025.

Will Johnson from the City of Columbus gave updates on design work for local let projects. The preliminary bridge layout was accepted for Steam Mill Road, and the right-of-way was approved. The 5th Avenue Trail Connector has been moved to the east side, and a concept report is being completed. The Liberty Theater Enhancements project is expected to let by the end of the year, while the Columbus River Walk repaving and maintenance is working on a bid. The South Lumpkin Road streetscape project will be a three-lane section. The 13th Ave/17th St/Blvd improvements and Ed Davis/Rustin Lake Road project are underway.

River Valley has forty-five projects in TIA-2. Thirty-one projects are in planning and design, four are in construction, and four are completed. Total expenditure for the projects as of November 26, 2025, is \$27,224,249.

#### **Update of Current Projects**

William Eastin, TIA Regional Coordinator, gave an update on completed resurfacing jobs and preconstruction updates for projects in TIA-2.

Lower Lumpkin Road in Georgetown-Quitman County let in June 2024. Striping and grassing have been completed, and final inspection will take place in December 2025. Cotton Hill Road in Clay and Randolph

Counties began construction between September and October 2025. Dooly and Crisp Counties' Cooney Road resurfacing project is currently advertising for a contractor. Bids open December 15<sup>th.</sup>

There are many projects in preconstruction. The design phases for Harris County SR 315 from Hart Drive to Hamilton, Mulberry Grove Rd, and SR 219 Intersection improvement projects are underway. The Buena Vista Road improvements, University Ave Road Diet/Streetscape, and 2nd Avenue improvement projects are under concept development. The Buena Vista Road improvement project will hold a public meeting on December 4, 2025.

There was some discussion on the utility and need for the University Road project as it was progressing. Todd Schuster made a motion to move the University Avenue Road Diet project to Band 2. Kathy Carlisle seconded the motion. The motion passed.

The right-of-way and final design processes are underway for the Webster and Schley Counties' bridge replacements. The Marion County Buena Vista Downtown project is currently working on final plans and right-of-way and will begin letting in March 2026. The Muscogee County Williams Road and Cusseta Road are finalizing contracts with design firms.

Preliminary Plans for the US 280 widening from Felder Street to District Line Road in Sumter County are being developed. The US 280 widening from District Line Road to SR 195 and the US 280 widening from SR 195 to Lake Blackshear are both working on environmental screening and Public Information Open House (PIOH) was held for both project segments on August 21, 2025, in Leslie.

Final plans are in place for the Montezuma Airport and Rustin Lake Road in Taylor County are nearly completed. The Man O' War Trail project has executed an agreement with the county and they are working on design. All of these are local let projects.

Will Johnson from the City of Columbus gave updates on design work for local let projects. Steam Mill Road is set to let in August 2026. The runway repaving has been completed for the Columbus airport. The Columbus River Walk repaving and maintenance is working on a bid, however, there has been a slight delay. The Liberty Theater Enhancements project is expected to let by May 2026. The South Lumpkin Road streetscape project is expected to let in June 2026. A concept report has been signed for the Whitesville Road project, and the project is expected to be a three-lane road. The 13<sup>th</sup> Avenue Roundabout project is about to let; however, there are right-of-way issues. The Morris Road and Forrest Road projects are in the design stage.
